A Wallside Windows crew arrived on 9/25 at 8:30 and completed installing all 12 energy-efficient windows by 1:30. These windows will definitely be a huge improvement over the aluminum window frames that were removed and we would hope to see an energy savings and greater comfort level, especially during the winter months, where previously, the winds blew easily through and around those old windows. Also, we will receive an energy credit of about \$20 per window from Consumers Energy. The cost of the windows was about \$5800.00 installed.

# **SHORT TERM RENTALS** (from Township Law E-Letter 9/2020)

Short-term rentals ("STRs") are generally considered owners and renters of houses listed on such sites as Airbnb, HomeAway and VRBO. The issue has gained significance in many communities throughout the country, creating hotly debated discussions over whether these uses are already allowed throughout various residential districts. And, if they are not allowed, whether a township should adopt regulations allowing them. The battle over STRs reached the highest court in Michigan in June 2020. The court system, however, is not the only area where STRs are being contested. Legislation has been actively introduced to preempt local control on the issue, and many groups are working with their local officials on developing ordinances that apply to STRs. There are no easy answers and no easy ordinances that can be put in place and not trip us up somehow. The debate continues. An issue that is problematic, is yes, we can and have put ordinances in place, but unfortunately, we cannot enforce those ordinances with the police staffing and patrol hours we currently have in place, as enforcement would be sporadic at best.
