## **OPERATING ORV'S AND GOLF CARTS IN SIMS TOWNSHIP ...**

There are many within Sims Township that drive ORV's and golf carts on the roads, but there are rules that need to be followed. Arenac County has an ORV Ordinance but no Golf Cart Ordinance. Sims Township follows the Arenac County ORV Ordinance, but we have our own Ordinance adopted in 2019 that governs golf cart use. The basic difference between the two ordinances is that the ORV Ordinance allows speeds up to 25 mph where golf cart speeds are limited to 15 mph. ORV's require a helmet while golf carts do not require a helmet. The age to operate an ORV is age 12, but for golf carts is age 16 and the operator must have a valid driver's license, and this is stipulated also in the State of Mi Vehicle Code,

Act 300 of 1949. Also, a golf cart must have DOT approved seat belts, front and rear lights, a rear-view mirror on the driver's side plus an interior rear-view mirror and a slow-speed triangle on the rear, a horn, mechanical or electrical and a windshield. Neither ORV's or golf carts are to be driven on sidewalks and must be driven to the far-right side of a roadway and travel in the same direction as normal vehicle traffic. Neither ORV's nor golf carts are to be operated on main trunk roads like US23 or I-75. Several residents have been stopped recently by the Arenac County Sheriff for "safety infractions" of one type or another or improper operation. I have reviewed our golf cart ordinance with our legal counsel, and we are revising it to clarify or tighten it up a bit. These changes are based on the State of Mich Vehicle Code, Act 300 of 1949 as discussed previously and it's all being done in the interest of safety and security. We are finding that many parents are allowing under-age children to operate ORV"s and golf carts on our roads, and this is not allowed and it's not safe. As soon as the board approves the ordinance revisions, we may be doing a special mailing to our residents, since there seem to be so many with both types of vehicles and many seem to be unaware of the rules.
